

Kemmerer Village is singing the praises of our Therapeutic Recreation! The Music Program is sending good vibrations into the world. What started out with a couple of guitars


and a piano has evolved into a full music room with keyboards, drums, guitars, ukuleles, piano, and the most recent addition, recorders.

Kemmerer Village Holds Dedication for Marie and Bob McNabb Lodge

July 25th a dedication ceremony was held to honor Marie and Bob McNabb's years of service and generosity to the children and families served at Kemmerer Village. As seen in the photo, Kemmerer Village was proud to dedicate the Marie and Bob McNabb Lodge. It was a special day for Bob and his children, family members, friends, Kemmerer Village Board of Directors and staff.

Bob shared a memory of his first connection to Kemmerer Village, during Christmas of 1945. As part of their service to the Tuscola Presbyterian Church, Bob's father volunteered to deliver Christmas gifts and food for the children at Kemmerer Orphanage. Bob was only 9 years old, but remembered being impressed with the home and history of caring for so many children. He felt that Mr. Philip Kemmerer's foresight and compassion to donate his house and farm for such a worthy purpose was inspiring.

Marie McNabb was the Stated Clerk for the Presbytery of Southeastern Illinois from 1991-2006. She was first elected to the Kemmerer Village Board of Directors in 1996, serving until 2016, the rest of her life. During her time on the Kemmerer Board of Directors, Marie served as President of the Board, participated in the planning, fundraising, and dedication of the new Margaret Dick Campus Center. In her early years with Kemmerer Village, Marie also

The building was in need of many updates and repairs. Fitted with all new windows, flooring, newly painted walls and updated bathrooms, the Marie and Bob McNabb Lodge is ready for visitors!


